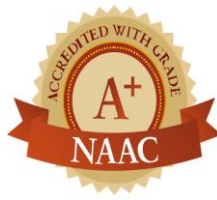

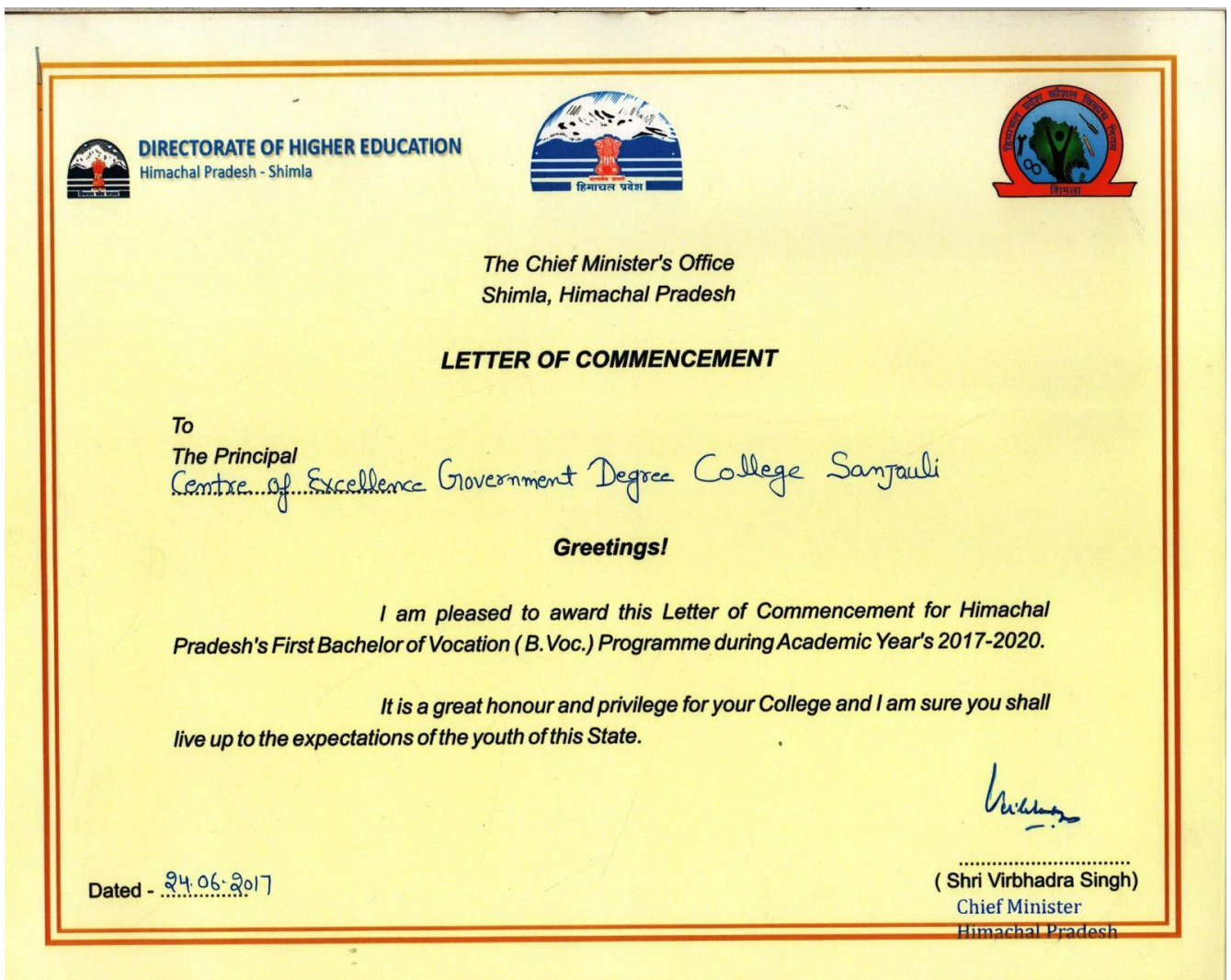


CERTIFICATE OF COMMENCEMENT
