Mr. Kapil Mohan Gautam, an eminent legal professional and a proud alumnus of Government College Sanjauli (Batch of 1993–1996, B.Sc. Non-Medical), led the sessions on two significant topics affecting society and educational environments.

- On 15th May, he explored the Narcotic Drugs and Psychotropic Substances (NDPS) Act, emphasizing its legal framework and the broader social impact of substance abuse, particularly within the student community.

- On **16th May**, he introduced key AI and Machine Learning concepts in an accessible way, equipping faculty with foundational knowledge of emerging technologies.
- On 17th May, Dr. Sharma focused on AI-driven teaching tools such as smart content generators, virtual assistants, adaptive assessments, and personalized learning pathways—demonstrating practical applications for classroom use.
