AND

Centre of Excellence, Govt. College Sanjauli, Shimla(hereinafter referred to as – COE, G.C.Sanjauli), herein referred as second party affiliated to Himachal Pradesh University Shimla, the college is imparting education mainly to rural youths in various disciplines i.e. humanities, science, commerce, B.Voc, BCA and BBA at undergraduate level. The admission in all disciplines in the first year of bachelor's degree courses is offered as per HPU norms. The college is recognized by UGC, New Delhi and is covered under section 2 (f) and 12 B of UGC Act. 1956. WHEREAS:

- CPU and COE, G.C.Sanjaulirecognize the need to promote academic, research, and professional collaborations for the mutual benefit of students and faculty.
- Both institutions acknowledge the importance of research, training & placement, career counselling, and industry Liaisoning for skill development and employability enhancement of students.
- 3. Both institutions desire to establish a framework for cooperation in the aforementioned areas.

NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. Objectives:

The primary objectives of this MoU are:

- 1.1. To foster a collaborative environment for research activities and projects.
- 1.2. To facilitate student and faculty exchange programs for academic and skill development.
- 1.3. To coordinate training and placement opportunities for students through joint efforts.
- 1.4. To organize career counselling sessions, workshops, and industry interactions for student development.

1.5. To strengthen industry liaisoning to bridge the gap between academia and industry requirements.

2. Scope of Collaboration:

2.1. Research Collaboration

- · Joint research projects, publications, and knowledge-sharing initiatives.
- · Exchange of research scholars and faculty for collaborative projects.
- · Access to research facilities and resources.

2.2. Training & Placement

- · Joint placement drives, internship programs, and skill enhancement sessions.
- Exchange of placement-related information and employer contacts.
- Development of industry-relevant training programs for students.

2.3. Career Counselling

- · Conducting career guidance workshops, seminars, and mentorship programs.
- · Providing professional development opportunities to students and faculty.
- Organizing guest lectures by industry experts.

2.4. Industry Liasioning

- · Facilitating industry-academia partnerships for internships, research, and training.
- · Conducting industry visits and industrial training programs.
- · Establishing tie-ups with corporate entities for collaborative activities.

3. Responsibilities of Both Parties:

- 3.1. Both institutions shall nominate a coordinator for effective implementation of this MoU.
- 3.2. The institutions shall share academic, research, and professional resources to achieve the objectives outlined above.
- 3.3. Each party shall ensure that the students and faculty members actively participate in the programs initiated under this MoU.
- 3.4. Both institutions shall jointly review and assess the impact of collaborative initiatives every year.

4. Duration and Termination:

- 4.1. This MoU shall remain in force for a period of five (5) years from the date of signing.
- 4.2. The MoU may be renewed upon mutual agreement of both parties.
- 4.3. Either party may terminate this MoU by providing a written notice of at least three (3) months to the other party.
