

ANDWHEREAS the SriBadrika Ashram Cum Charitable & Social Welfare Socie
ty is desirous of recording a M emorand um of Understanding with the University,
whereastheSocietyisintended to provide the "Sri Badrika Ashram
Emerging Youth Scholarship(पढ़ोऔरबढ़ो)" to reward a student's
academic achievement and educational progression and help deserving
students who want to graduate with their degree and give back to
society. Also the Society believes and promotes the importance of
education and the role it plays in shaping the future of students.

**NOW, THEREFORE,** this Memorandum of Understanding witnesseth asfollows:

- 1. That Sri Badrika Ashram Cum Charitable and Social Welfare Societyisdesirousofawarding the "SriBadrikaAshramEmergingYouth Scholarship (पढ़ोऔरबढ़ो)" to bright and needy students to support the aspirations of students who hope to build on their achievements in university and to make significant contributions to society.
- 2. That Sri Badrika Ashram Emerging Youth Scholarship
  (पढ़ोऔरबढ़ो)provides between 50% to 100% of the tuition fee
  ofamaximumof\_\_\_\_\_orasmaybedecided by the Society from
  timetotime.
- 3. That Sri Badrika Ashram Emerging Youth Scholarship (पढ़ोऔरबढ़ो)will be provided to the students who are enrolled as a full timestudentintherecognized/deemedUniversity.
- 4. That the eligibility to receive the award, the candidate must fulfillthefollowing requisites:
  - a) That the candidate must be enrolled as a full time student inan undergraduate degree/ diploma in the University.
  - b) Thatthecandidatemustbea HimachalPradesh residentholdingaHimachalPradesh domicile. The students who are not residents of Himachal Pradesh and do not hold domicile can be considered on a case-by-case basis solely at the discretion of the Society.

- c) Thatthecandidatemustbemeritorioushaving scoreda minimum of 60% for the BPL category and 75% for the other categoryin 12<sup>th</sup> standardtoavailthebenefitofscholarshipforwhichsigned and attested photocopies of documents must be submitted by the University.
- d) The eligibility criteria for shortlisting of students to avail the scholarshipshall beeitherof following:
  - i. Students from below poverty line(BPL) families (BPLCard is required) with minimum of 60% marks in 12<sup>th</sup>grade or
  - ii. Student belonging to a family with an annual incomebelow Rs. 3.00 lacs (Income proof Certificate from Tehsildar/SDM is required) with minimum of 75%marksin12<sup>th</sup>grade.
- e) In case the student belongs to d(ii) category specified above, then(s)heshouldbelongtooneormoreofthefollowingsub-categories to be eligible for this scholarship. The order ofpreferenceshallbeasunder:
  - i. Orphanedstudents
  - ii. Singleparenthouseholds-motherorfatherare separated, expired
- iii. Families with cases of chronic/terminal illness suchascanceretc.
- iv. Students whose parents are engaged inmanual jobs such as daily wage labourers, ex-servicemenfromthe

IndianArmedforces.

- v. Familieswithmultipledaughters
- vi. MeritoriousStudentswho haveattainedmorethan90%in12<sup>th</sup>grade.
- f) That the students shall be considered for this scholarshipprogram on a first cum first serve basis as referred by theUniversity.
- g) Among the eligible students, selection of the awardee will bedone as per the Society's selection process. The Society willhave complete autonomy in deciding the awardee, based onitsinternalselection criterion.
- h) That a student taking admission under the management quota shall not be considered for this scheme.
- i) That the total number of students from the University to be considered underthe scheme shall be a maximum of all eligible studentswho meetthe Society's internal selection process unlessanduntilthe Societydecidesotherwise.
- j) TheSociety's student selectionprocessshallbeinthefollowingorder:
  - i. Shortlisting of students provided by the University based on the eligibility criteria below:
    - a) BPLCategory
    - b) Otherincomecategoryinorderoflowesttohighestwithth eorderofpreferenceasmentionedinpointno.4(e).

- ii. An initial screening over a phone call to determine authenticity of the students' background.
- iii. A personal interview via video call with the Society's executive team to further understand students' candidature.
- k) Thatthecandidatemustbeargoodconduct/character.
- l) ThattheUniversitymustsubmitt h e followingduly certified documentsalongwitha scholarshipapplicationform:
  - i. Aadharcard
  - ii. Mark sheets of 10<sup>th</sup>& 12<sup>th</sup> grades
  - iii. Marksheetsofprevioussemestersfor students in2<sup>nd</sup>year onwards
  - iv. FamilyIncomeproof/BPLCard
  - v. Ration card
  - vi. AnyotherdocumentrequiredbytheSociety
- 5. That to continue to receive the award from 2<sup>nd</sup>year onwardsthe University willbe required to submitthe followingdocuments:
  - i. Certificate that the candidate has maintained 75% or aboveattendanceduringtheprecedingsemesters of year.
  - ii. Mark sheet for the previous year semesters showing 60% ofmarks.
  - ii. An undertaking that the student is not receiving a scholarship from anyother private or government or ganization.
  - iv. An undertakingthatthestudentbearsgoodconductandbehavior.

- 6. That the scholarship amount shall be transferred to the University designated account directly.
- 7. That the Scholarship is nontransferable at the behest of the student/University/College.
- 8. That it is agreed between the parties that the
  University/Collegewill recognize and appreciate the donor and
  make appropriateannouncements through internal, external
  publications and tothe media. It shall be the responsibility of the
  University to take appropriate measures to announce the presence
  of the

SriBadrikaAshramEmergingYouthScholarship(पढ़ोऔरबढ़ो)inits brochures, onits websiteand. The University will acknowledgethecontributionmadebytheSocietyinvarious print and digital media and also recognize the scholarship scheme in the Annual Report published by the University.

- 9. That the University/College has authorized \_\_\_\_\_\_(Designation, Department & Mobile Number) &\_\_\_\_\_\_(Designation, Department & Mobile Number) to be the main points of contact for all correspondence and handling of this scholarship scheme.
- 10. That the University will verify and send the profiles of eligible candidates to the Society. The Society reserves its right to decide the candidates to be awarded with the scholarship and its decision will be final which will be informed to the University.
- 11. That the Society reserves the right to terminate the Scholarship

ofany student or all of them at any time at the sole discretion of the Society and the University/College has no recourse to bind the Society in anymanner.

- 12. Thatthescholarship awardsshallbeawardedtothestudentsinsuccessive years until graduation provided the recipient maintainseligibility.
- 13. That the MOU shall be effective from the date of signing and shallremain in force for a period of 5(five) years. It shall automatically renewed for next 2 years until & unless discontinued by either party with prior notice of three months before renewal date.
- 14. Thateither the Society or the University can terminate theMOUwith a minimum of three months' advance notice by providing a duly certified and signed written termination letter.
- 15. That all notices or other communications under or in connectionwith this MOU shall be given in writing and shall be deemed to besufficiently given if they are forwarded by registered post A.D./hand delivery with acknowledgment to the Chief Administrator of Sri Badrika Ashram and to the representative of the University asspecified in point no. 9 above.

That in the event of dispute between the Society and the University arising out of, or relating to this MOU, its interpretation orperformancehereunder, the parties shall exert be stefforts to resolve the disput

ethrough negotiations.
